Equipment Protection Plan/Damage Waiver Memo

Dear Valued Customer:

Many of our customers have been asking about insurance on rented equipment. In most instances insurance policies cover you for liability to third parties for damages or injury caused while you are using rented equipment. However, you are responsible for returning the equipment in the same good working condition that it was received.

We are pleased to offer an Equipment Protection Plan that will protect you from damage to the equipment you have rented due to circumstances beyond your control. The program provides that we will waive our right to recover from you the loss resulting from accidental physical damage to rented equipment, such as that resulting from collision, upset, fire, vandalism, and other similar type losses. Excluded in this plan are damages or malicious mischief unreported to the police and theft. NOTE: The Damage Waiver or Equipment Protection Plan is not insurance. It does not cover abuse, misuse, or theft of property.

The cost of this Protection Plan is 8.99% of the total rental for all rental equipment. When you compare the cost of our Protection Plan to the cost of insuring rented equipment under a contractor equipment floater policy, we believe you will find it a good value.

If you do not wish to participate in our Equipment Protection Plan, we require a “Loss Payable Certificate” with Hejny Rentals, Inc. named as Loss Payee from your insurance company. Payment of our invoices including the Equipment Protection Plan or incomplete credit applications will be considered acceptance of the plan. We reserve the right to cancel this plan by mail.
